Format: The event will consist of tests in a single venue.

Tests: The tests will be designed to suit everyone & will be easy to memorise.

Tests will be of an open nature & suitable for Road Going & Endurance Trial Cars. Use of Seatbelts is compulsory.

LICENCE REQUIREMENTS:

Competitors must hold a valid 2025 Motorsport Ireland competition licence or MSUK equivalent. This must be produced at sign-on. **One Event Licences also available via www.motorsportireland.com/licences ONLY.**

One Event Licences can be purchased online in advance of the event.

Note: Under 18 year olds cannot obtain a One Event Licence.

Junior Licence (Clubman) is free for 13 to 16 year olds and the Minor Entrant Licence for the Parent/Legal Guardian (Clubman) is also free. Both sourced through the Motorsport Ireland Web link.

PENALTIES:

- All junior competitors will run on all tests.
