The event will be an open Loose Surface Autocross held under the General Competition Rules of Motorsport Ireland (incorporating the provisions of the International Sporting Code of the FIA), Appendix 85.3 86 & 87 of the current Motorsport Ireland Yearbook, these supplementary regulations, and any further regulations which may issued. Any Driver not signed on by 10am on the day of the event may be excluded

ENTRIES:

Entries are open to all drivers whom hold a current valid competition licence and log book which must be produced at scrutiny. Entries are limited to a maximum of 65 competitors. Entries will be accepted on a first-come first-paid basis. Entries will only be accepted online via Stopastride. If more than 65 entries are received, a reserve list will operate. Entries from other (non-MI/MSUK) ASN licence holders from abroad may be accepted provided:

- The licence holder has written permission from his/her ASN (National Governing Body) to compete in the declared "national competition organised abroad.
- The licence holder holds a licence of an appropriate grade.
- The Motorsport Ireland (MI) office has been contacted in the first instance and has given PRIOR approval for each individual competitor before an entry can be accepted. Written proof of which must be provided to the organisers

Competitors will be excluded from the results for the following offences:

- 1 Unofficial Practice in any type of vehicle.
- 2 Failure to wear safety belt, crash helmet of the approved type while on the course.
- 3 Failure to have appropriate type fire extinguisher in the car at all times during the event
- 4 Failure to pass scrutiny or to arrive at scrutiny after practice has begun.
- 5 Failure to obey a reasonable request from an official.

Entry Fee of €140 Main field, €90 for Class 8, 9 and 13 competitors, inclusive of Personal Accident Premium.

Once your online entry has been received and paid, it will then be acknowledged by the Entries Secretary. Unpaid Submitted entries will remain unacknowledged.

A competitor who wishes to withdraw their entry must contact the Event Secretary on or **BEFORE** 1pm Saturday, September 19th, otherwise the full entry fee will not be returned.

All competitors must be in possession of a valid competition licence and vehicle logbook.

SCRUTINY:

- All competition vehicles must pass scrutiny in accordance with Appendix 2, 86 & 87 of the current MI Yearbook.
- Car bodywork must be in presentable condition.
- Safety equipment **MUST** include a safety harness and a securely fitted 1.75 Kg minimum AFFF (or FIA Approved equivalent) Fire Extinguisher, as per Appendix 2 of the current MI Yearbook.
- Helmets, FHR devices and protective clothing must comply with standards set out in Appendices 2 & 5 for Autocross events in the current MI Yearbook.
- Mud flaps are obligatory on all wheels.
- Please co-operate with marshals and officials.
- As per Appendix 86 9.8, Smoking is strictly prohibited in the Paddock or Service Area.

SCRUTINY REQUIREMENTS

- All competing vehicles must carry a Seat Belt Cutter
- All cars must pass scrutiny
- All cars must be fitted with fire extinguishers of approved type
- All cars must be fitted with full roll cage and have laminated windscreens.
- All cars must be fitted with FIA approved seats. Fire proof clothing must be worn as per MI regulations.
- Overhead/ floor skid pans and side netting are compulsory on specials.
- Seats, safety belts and helmets of approved type must be used. See specification in current yearbook and latest MI bulletins.

MULTIPLE DRIVERS:

- A maximum of three drivers will be permitted per competing car.
- Each driver will be permitted one untimed familiarisation run during which stopping or holding back unnecessarily on the track is prohibited. Classes 8, 9 & 13 should complete a minimum of two laps. This is not a competitive run.
- You must notify the Event Secretary when entering if you intend to double or treble drive with another competitor. Please ensure the first individual double driver is prepared to start their run early to ensure there are no hold ups or delays. Please ensure double drivers are ready to take their turn as soon as the first driver finishes their timed run

COMPETITION:

Overtaking is not allowed.

Any competitor who feels he/she has been baulked/delayed by another competitor or has been yellow flagged by a Marshal can request a re-run but must do so immediately on return to the Paddock. A re-run will only be granted at the discretion of the Clerk of the Course.

Deliberate delay in taking a run as scheduled will result in forfeit of the run.

Unofficial practice, failure to pass scrutiny or late arrival will lead to exclusion. All cars must comply with appendix 2 of the current M.I Yearbook-Scrutiny requirements. A maximum of 3 drivers per car will be allowed but the onus will be on the competitors to have the correct competition number clearly displayed. The club accepts no responsibility for mistakes in timing due to the wrong number being displayed.

Dangerous driving and Unruly Behaviour will be dealt with by the COC.

The official Timekeepers, Officials and Flag Marshals will be Judges of Fact and will be deemed to be correct at all times. Protests will only be accepted as per MI regulations. No case for force majeure will be considered once a competitor has started the event. The appropriate fee must accompany protests.

PENALTIES:

Penalties will be applied as per Appendix 86, Art. 2 in current yearbook.

Competition cars must not leave the venue under their own power at any time, before, during or after the event. The penalty for breach of this regulation is EXCLUSION.

TIMING & RESULTS:

Timing will be to the nearest 1/100th second from a standing start to a flying finish and in accordance with Appendix 86 Art. 9.7 of the current Motorsport Ireland Yearbook.

The Timekeeper's times will be judged as final and correct.

Results will be based on a competitor's fastest time (including penalties) for 1 run. The competitor with the overall fastest time (including penalties) for 1 run will be the winner. If a competitor is unable to complete a timed run, a run maximum of 10 minutes will be applied.

CLASSES:

- 1 All Saloon cars up to 1450cc.
- 2 All Saloon cars from 1451cc to 1650cc with not more than two valves per cylinder.
- 2A Rally 4 cars in accordance with FIA Appendix J 260 inc Ford Fiesta R2T2019 (Homologation no A5775)
- 3 All Saloon cars from 1451cc to 1650cc with more than two valves per cylinder.
- 4 All Saloon cars from 1651cc to 2100cc
- 5 All Saloon cars over 2100cc, 4WD & Turbo Charged Saloon Cars.
- 6 Motorcycle Engined Specials over 1250cc up to 1400cc Maximum. Only open to competitors 17 Years and over.
- 7 Car Engined Specials. Only open to competitors 17 Years and over.
- 8 "Intermediate class" for 16-18 year olds, holding a "Speed National B" licence in saloon cars up to 1650cc
- 9 "Junior Saloon Class" for 13-16 year olds holding a "Junior" Licence in Saloon Cars up to 1450cc.
- 10 Motorcycle Engined Specials including Buggies up to 600cc. Only open to competitors 17 Years and over.
- 11 Motorcycle Engined Specials including Buggies from 601cc to 750cc. Only open to competitors 17 Years and over.
- 12 Motorcycle Engined Specials 751cc to 1249cc. Only open to competitors 18 year and over.
- 13 "J1000", For holders of Junior Speed or Junior Rally C licences with cars complying to J1000 Technical Regulations as published on MI website, Co drivers are compulsory and must hold a minimum of National B competition licence and be 21 years old or over. Drivers must be 12 - 16 years of age.

Notes on classes:

Drivers in Class 8, 9 & 13 must be within respective age limits on the first day of the Championship year
Maximum engine capacities are as follows:

Motorcycle Engine Buggy is 1000cc, Motorcycle Engine Special is 1400cc, Car Engine Special is 4000cc
The onus rests on the Competitor to enter a class for which their car is eligible.

**AWARDS:**

FTD Specials/Buggies. (Class 6, 7, 10, 11 & 12)

FTD 2WD Saloons (Class 1, 2, 3, 4, 8, 9 & 13)

FTD 4WD Saloons (Class 5)

Class Awards: 1st, 2nd and 3rd awards in each class regardless of the number of competitors.

Ladies Awards: should also be made for 1st, 2nd and 3rd in the Ladies not receiving another class award.

Novice Award: should be made for the best Novice where applicable.

Highest place Club Member not receiving any other award.
